TO INCREASE MEMBERS' CAPACITY TO ELIMINATE BIAS AND INCREASE EQUITY ACROSS THEIR GRANTMAKING LIFECYCLE, WE HOSTED 3 VIRTUAL WORKSHOPS BY THE BME COMMUNITY THAT HELPED US LEARN TO FOCUS ON APPLICANT'S ASSETS AND LEARNED ABOUT HOLISTIC GRANT REVIEW FROM THE AAMC. WE CONTINUED TO HOST VIRTUAL CEO ROUNDTABLES SEVERAL TIMES A YEAR WHICH LED TO OTHER ACTIVITIES SUCH AS HOSTING TARGETED WEBINARS AND CREATING RESOURCES. WE ALSO CREATED A PROFESSIONAL DEVELOPMENT PROGRAM FOR STAFF AT HRA MEMBER ORGANIZATIONS. OUR FIRST VIRTUAL WORKSHOP WAS "UNDERSTANDING YOUR LEADERSHIP STYLE" TO INCREASE INDIVIDUAL SKILLS AND TO FACILITATE NETWORKING AND PEER MENTORING.

HRA ALSO SURVEYED OUR MEMBERSHIP TO UNDERSTAND THE PANDEMIC'S ORGANIZATIONAL IMPACTS ON REVENUE, RESEARCH GRANTS AND PROGRAMMING AND PUBLISHED THAT ANALYSIS. WE PUBLISHED A REPORT OF THE FINDINGS WHICH
